

Announcement – Lisbon, 17 April 2025

Conclusion of the share buy-back programme and final report on the transactions carried out

CTT – Correios de Portugal, S.A. ("CTT" or "Company") hereby informs that that the share buy-back programme of the Company ("Buy-back Programme" or "Programme") announced on 19 July 2024 has been concluded. Under this Programme, 4.620 million own shares were purchased for a total amount of 25 million euros.

From 2022 to the present date, CTT has carried out three share buy-back programmes for an overall amount of 66.5 million euros, having acquired 16.18 million¹ shares representing 7.71% of CTT's share capital prior to the two programmes². Of these 16.18 million shares, 6.085 million³ shares corresponding to the first programme and 5.475 million⁴ shares relative to the second programme were cancelled. The 4.620 million shares relative to this Programme will be cancelled in due course, as approved at the Annual General Meeting to be held on 30 April 2025.

Additionally, CTT informs that in the period from 11 to 17 April 2025 (inclusive) JB Capital Markets, S.V., S.A.U. has acquired 192,747 shares representing CTT's share capital, under the share buy-back programme ("Buy-back Programme") and as the financial intermediary in charge of the execution of said programme, in Euronext Lisbon ("XLIS") regulated market and/or on the trading platforms CBOE Europe – DXE Lit Order Book (NL) ("CEUX"), Aquis Exchange Europe SAS ("AQEU") and/or Turquoise Europe ("TQEX") as detailed in the table below (aggregated information):

Pursuant to the terms and conditions of the Buy-back Programme, CTT also hereby informs that, having acquired the 25 million euros announced, the Programme should be considered concluded on this date, before the end of its maximum duration period (from 22 July 2024 to 22 July 2025 (inclusive)). As at 17 April 2025, the Company had already acquired 4,620,000 shares under the scope of the Buy-back Programme announced to the market on 19 July 2024. The price paid for these acquisitions amounted to a total of &24,945,413.

As a consequence, on this date, the Company holds an aggregated total of 5,908,046 own shares, representing 4.27% of its share capital. Further detailed information on all transactions carried out under the Buy-back Programme, in the period from 11 to 17 April 2025 (inclusive), may be found in the tables attached hereto as Annexes 1 to 5.

As the sole purpose of the Buy-back Programme was to reduce CTT's share capital through the cancellation of own shares acquired under the Programme, the Board of Directors submitted for approval of the 2025 Annual General Meeting of CTT to be held on 30 April a proposal to reduce its share capital by up to \leq 4,250,000, corresponding to the cancellation of up to 8,500,000 own shares, representing 6,14% of the Company's share capital.

As disclosed to the market in due time, on 22 July 2024, CTT started trading in the context of the Buy-back Programme, pursuant to the terms and limitations set forth in (i) the resolution adopted under item 6 of the Agenda of the 2024 General Shareholders' Meeting of CTT granting authorisation for the acquisition and transfer of own shares by the Company and its subsidiaries, as set forth in such shareholders' resolution and subject to a decision of the Company's Board of Directors, and (ii) the





resolution of the Executive Committee of 19 July 2024, based on the delegation of powers granted by the Board of Directors of CTT at the meeting of 20 June 2024, under which a share buy-back programme was approved, the main terms and conditions of which may be found in the announcement regarding the start of trading within the Buy-back Programme disclosed to the market on 19 July 2024.
