We hereby notify you of a qualifying shareholding, under article16, 2(b), of the Portuguese Securities Code.

Accordingly, we notify you that:

- a) As of 20 April 2015, the investment funds managed BNP Paribas Investment Partners, Limited Company hold a total of 3,063,008 shares, corresponding to 2.04% of the share capital, relative to 1.97% of the voting rights, having thus crossed the 2% qualifying holding threshold (share capital), which is broken down as indicated in the table attached to this letter.
- b) The holding of a qualifying shareholding took place on 20 April 2015.
- c) The holding of a qualifying shareholding occurred as a result of the acquisition of 75,300 shares.
