Interim report on the transactions carried out in the context of the share buy-back programme

CTT – Correios de Portugal, S.A. ("CTT" or "Company") hereby informs that in the period from 22 to 25 July 2024 (inclusive) JB Capital Markets, S.V., S.A.U. has acquired 67,879 shares representing CTT's share capital, under the share buy-back programme ("Buy-back Programme") and as the financial intermediary in charge of the execution of said programme, in Euronext Lisbon regulated market, as detailed in the table below (aggregated information):

As at 25 July 2024, the Company had already acquired 67,879 shares under the scope of the Buy-back Programme announced to the market on 19 July 2024. The price paid for these acquisitions amounted to a total of €316,824.

As a consequence, on this date, the Company holds an aggregated total of 1,356,362 own shares, representing 0.98% of its share capital. Further detailed information on all transactions carried out under the Buy-back Programme, in the period from 22 to 25 July 2024 (inclusive), may be found in the tables attached hereto as Annexes 1 to 4.

As disclosed to the market in due time, on 22 July 2024, CTT started trading in the context of the Buy-back Programme, pursuant to the terms and limitations set forth in (i) the resolution adopted under item 6 of the Agenda of the 2024 General Shareholders' Meeting of CTT granting authorisation for the acquisition and transfer of own shares by the Company and its subsidiaries, as set forth in such shareholders' resolution and subject to a decision of the Company's Board of Directors, and (ii) the resolution of the Executive Committee of 19 July 2024, based on the delegation of powers granted by the Board of Directors of CTT at the meeting of 20 June 2024, under which a share buy-back programme was approved, the main terms and conditions of which may be found in the announcement regarding the start of trading within the Buy-back Programme disclosed to the market on 19 July 2024.
