We hereby notify you of a qualifying shareholding, under article 16, 2(a), of the Portuguese Securities Code.

Accordingly, we notify you that:

- a) The investment funds managed by BNP Paribas Investment Partners, Limited Company hold a total of 7,538,174 shares as of 16 December 2015, corresponding to 5.03% of the share capital, (4.77% of the voting rights), having thus crossed the 5% qualifying holding threshold (shares), which is broken down as indicated in the table attached to this letter.
- b) The holding of a qualifying shareholding took place on 16 December 2015.
- c) The holding of a qualifying shareholding occurred as a result of the acquisition of 188.731 shares."
