- a) As of 22 April 2015, the investment funds managed by BNP Paribas Investment Partners, Limited Company hold a total of 3,466,545 shares, corresponding to 2.31% of the share capital, relative to 2.23% of the voting rights, having thus crossed the 2% qualifying holding threshold (voting rights), which is broken down as indicated in the table attached to this letter.
- b) The holding of a qualifying shareholding took place on 22 April 2015.
- c) The holding of a qualifying shareholding occurred as a result of the accumulated acquisition of 365,374 shares. ”
