GUIDE TO SHAREHOLDERS AND REPRESENTATIVES



This guide will help you to register and participate in the meeting either by **Video Webcast** and/or **Conference Call**.

Please note that the links to participate will only be made available to the Shareholders and representatives that till 26 April have voted either by electronic correspondence or electronic vote as per the notice to convene.


To join the meeting by **Video Webcast** please follow these steps:

1. Open the link sent by CTT. You will land in this authentication page:




As this will be the first time you're attempting to join the Video Webcast, you will need to click on: "If you are not registered in the webcast, please sign up here".


2. Then, you will be redirected to the Registration page:



- 3. You will need to fill in the fields and click on the "Register" button.
- 4. After filing in the fields, you will receive an email with a link and a password to join the webcast.
- 5. Click on the link received by email and you will be redirected to the authentication page. Enter your email and password and then click the "submit" button.



After this, your Access to the webcast will be completed and you will see a website page like the one below:



In this page you can choose (bottom right of the page) the language in which you want to follow the meeting: Portuguese, English or Original version.

6. If you want to ask a question, just click on the "Ask a question button" and write your question. Then click on the "Submit" button:



7. If you need assistance with the Video Webcast, click on the "?" button (bottom right of the page).

Please note that our platform is responsive to all devices, so you can follow the Video Webcast from your computer, tablet or mobile phone.

To join the meeting by **Conference Call** please follow these steps:

- 1. Dial in the number provided by CTT
- 2. An operator will answer your call and ask for your name and surname.
- 3. During the Q&A session if you would like to put a question please press *1 on your telephone keypad.
- 4. The operator will open your line for you to put the question whenever it's your turn.
- 5. If you require assistance during the call press *0

Personal Data Protection

The subjects of personal data may, at any time, exercise their rights of access, rectification, erasure, opposition, limitation of processing or portability of personal data, as provided for in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, as amended, as well as in Law 58/2019 of 8 August 2019 and other applicable legislation.
