In accordance with article 16 of the Portuguese Securities Code and articles 2 and 2-A of CMVM Regulation 5/2008, JPMorgan Asset Management Holdings Inc of 270 Park Avenue, New York, NY 10017, USA, hereby notifies you that it has a qualifying holding in the issued share capital and voting rights of the above company, as detailed in the schedule attached.

The reason for the disclosure is the crossing of the 2% threshold by one of its subsidiaries, JPMorgan Asset Management (UK) Limited.

The total number of shares held (indirectly, as detailed below) by JPMorgan Asset Management Holdings Inc. on 27 January 2015 increased to 3,174,992 shares representing 2.12% of the issued share capital and the voting rights of the above company. The increase was the result of off-exchange purchases totalling 107,549 shares by JPMorgan Asset Management (UK) Limited. As a result of the purchase the number of shares and equity swaps held by JPMorgan Asset Management (UK) Limited increased to 3,001,549 or 2.00% of the issued share capital and voting rights of the above company.
